

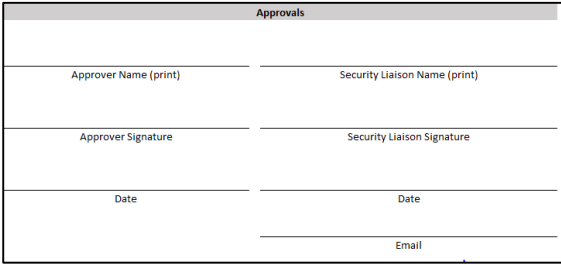

Requesting Smart HR Security Access

Notice: Department Processors who have attended Smart HR Training but were not submitted as Payroll Authorization Processor in the Task 10 Security Workbook will need to have their department's Security Liaison submit the **Core-CT Security Request Form** to request them security access to Smart HR templates in Core-CT.

Step	Action	Screenshot
1	<p>Navigate to: http://ess.uconn.edu and look under the Related Links section.</p> <p>Confirm with your department's Readiness Council Member that you were <u>not</u> listed as a PA Processor on the final Task 10 Security Workbook.</p>	
2	<p>Contact your department Security Liaison to submit a Core-CT Security Request Form. Include the following information in your request:</p> <ul style="list-style-type: none"> Name Employee # Department Course number(s) that you attended (<i>HCM101, HCM102, HCM105 or HCM200</i>) Date you attended the training course(s) Smart HR template(s) you need access to* <p>*Note: Only request access to the template(s) you need access to to perform your job responsibilities.</p> <p><i>The list of all available template selections is at the bottom of this job aid.</i></p>	
3	<p>Ensure your department Security Liaison completes the Core-CT Security Request Form. The Security Liaison will enter the following:</p> <ul style="list-style-type: none"> Employee # Employee Name Request Date Request to Add or Remove Department(s) Department(s) to Add or Remove Request to Add or Remove Template(s) Template(s) to Add or Remove

4	<p>Your department Security Liaison will need to print the Core-CT Security Request Form and gather wet signatures from the following:</p> <ul style="list-style-type: none"> • Approver (<i>your Readiness Council Member and/or Security Liaison will know who the Approver is</i>) • Security Liaison 	
5	<p>Your department Security Liaison will need to scan a copy of the approved Core-CT Security Request Form and send it to: HCM_Security@uconn.edu</p> <p>The security request will be addressed in a timely manner. Once complete, the Payroll Security Administrator will notify the Security Liaison via email that the request has been completed. Your department Security Liaison will then communicate back to you that your access is granted.</p>	
6	<p>Once you are granted the correct Smart HR template access, it is recommended to clear your computer's cache and cookies. Refer to the Clearing Your Cache and Cookies job aid to perform these steps.</p>
